



Basic/Expert Trademark License, 2023

This Basic/Expert Trademark License (the "License") is a royalty-free, non-exclusive agreement between Goblinoid Games and third-party publishers. This License is non-sublicensable, and grants publishers the limited use of the product trademarks listed below.

Goblinoid Games reserves the right to revise or retract this License at any time, but any products published under a previous version of the License prior to the release of a new version or the retraction of the current License will be grandfathered in, meaning that these products may remain in print and/or distributed electronically. Products produced under a previous version of the License may not be published in any revised form unless the revised product adheres to the terms of the current License. If the License is retracted, products may not be revised for release under any previously existing License without express permission from Goblinoid Games.

Goblinoid Games further retains the right to retract permission to use this License from specific publishers and individuals. Permission may be retracted for a specific product or for all products from a publisher. In such cases, Goblinoid Games may require the publisher to cease the sale of any product produced under any version of this License, and may require the destruction of existing and unsold product.

Third-party publishers do not need further written permission than what is provided in this License, unless otherwise noted, to begin producing material if the terms of this agreement are met.

Publishers in compliance with the terms of this License may do the following:

For the purposes of this License, a "complete game" is defined as any work that any player can use for character generation and/or reference in game play without the need of the rule books associated with the trademarks. As a general guideline, if the work is so complete as to make any core rule book obsolete to any players, it fits the definition of a complete game for the purposes of this License. Goblinoid Games retains the right to decide what is publishable.
- The copyright page or similar notification of each work must contain the following text: "[Trademark used for the product] is a trademark of Daniel Proctor. These trademarks are used under the Basic/Expert Trademark License, available at www.goblinoidgames.com."
- All products must be in compliance with the terms of the Basic/Expert Trademark License current to the date of any product's original publication or the date of a revised publication.
- The Publisher agrees to refrain from publishing any materials under this License that contain hate speech or defamatory language towards any person or group of people, regardless of race, gender or gender identity, sexual preference, religion, nationality, or any other characteristic.
